Continuous File Monitoring

A lightweight agent monitors designated folders for any file changes. The moment a file is saved, modified, or created, a new version is captured and queued for upload.

Encrypted Cloud Upload

All backup data is encrypted in transit and at rest — sent to Datto's secure cloud infrastructure with redundant storage across multiple geographic regions.

30-Day Version History

Every version of every file is retained for 30 days — enabling point-in-time recovery to any previous state, not just the most recent backup.

Managed Recovery

Degarmo Technologies manages all restore operations — locating the correct version, initiating the transfer, and verifying successful recovery on your behalf.

User Profile & Documents

All user profile folders — Documents, Desktop, Downloads — are protected by default. Additional folders are configured per your environment.

Local Business Data

Any data stored locally that is not synced to a file server or cloud drive — the most vulnerable data in your environment.

Project & Creative Files

Large project files, design assets, and work-in-progress data that employees save locally for performance reasons.

Configuration & Settings

User-specific application configurations that would need to be manually recreated after a device failure.
